Dublin Oak Academy Child Safeguarding Statement

This statement has been prepared to comply with the requirements of the Children First Act 2015 and is derived from Safeguarding Children Policy and Standards for the Catholic Church in Ireland 2016.

Statement

As a constituent member of the Catholic Church in Ireland, the Legion of Christ recognise and uphold the dignity and rights of all children and are committed to ensuring their safety and well-being and will work in partnership with parents/ guardians to do this. We recognise each child as a gift from God, and we value and encourage the participation of children in all activities that enhance their spiritual, physical, emotional, intellectual and social development.

All personnel (including clergy, religious, staff and volunteers) have a responsibility to safeguard children through promoting their welfare, health and development in a safe and caring environment that supports their best interests and prevents abuse.

Nature of service and principles to safeguard children from harm

The Legion of Christ as a constituent member of the Catholic Church in Ireland exists to promote the teachings of the Catholic Church. This includes working with children, as defined in the Safeguarding Children Policy and Standards for the Catholic Church in Ireland 2016 at our Irish Institution **DUBLIN OAK ACADEMY**.

Dublin Oak Academy is an international, private, boarding school in Ireland that strives to provide the most appropriate environment, facilities, educational and sports programs, and personnel to achieve an Integral Formation of young men as Christian leaders.

Our education is rooted in the living Catholic tradition of academic excellence, personal integrity, high moral standards and a spirit of service to others. It aims to offer each student the key to his personal happiness and fulfilment in this life and the next step of his life.

There are currently 95 students residing at Dublin Oak Academy for the 18/19 Academic Year. Dublin Oak has a capacity for 110 students. There are 7 non-resident teachers at the Academy teaching the students the Secondary school Irish Curriculum. There are 6 Religious and 4 co-workers (age profile 18-20) who reside on site. The students study the Irish Curriculum during the school day, followed by sports/activities each day, with one outing per week on a Sunday, outside the Academy.

During the year, the students participate in two main trips as part of their Tuition and have the choice to participate in three other optional trips within Europe. All trips are authorised by parents/guardians. If students do not participate in the optional trips, they reside at the Academy and take part in organised activities and outings during this period.

As outlined in the Safeguarding Children 2016 Policy and Standards for the Catholic Church in Ireland we are committed to the following principles:

• Mandatory reporting

Each of us has a duty to notify the statutory authorities of suspicions, concerns, knowledge or allegations that a child is being or has been abused:

- Physically
- Emotionally
- Sexually
- Through neglect

Suspicions, concerns, knowledge or allegations may relate to possible abuse by a member of Church personnel, but they can also relate to incidents in the child's family, or elsewhere in the community.

• Caring for the welfare of all children and the adults who work with them

Measures to create and maintain environments that are safe for children, that prevent abuse and that create nurturing, caring conditions within the Legion of Christ Institutions in Ireland for children and the adults who work with them, will continue to be strengthened and reviewed. This will be done through training support, communications and quality assurance.

Responding appropriately to child protection suspicions, concerns, knowledge or allegations

Anyone who brings any suspicion, concern, knowledge or allegation of current or past abuse of a child to the notice of the Legion of Christ Institutions in Ireland will be responded to sensitively, respectfully, actively and in a timely manner, in line with statutory child protection procedures and Church requirements.

All suspicions, concerns, knowledge or allegations that reach the threshold for reporting to the statutory authorities (apart from those received in the Sacrament of Reconciliation) will be reported to the appropriate statutory authorities. This will be done irrespective of the status of the person (lay, cleric or religious) who is suspected of having been abusive to a child. If the allegation relates to a lay member of Legion of Christ personnel, in addition to notifying the statutory authorities, the allegation must be reported to the Church authority.

If the allegation relates to a cleric or religious, in addition to notifying the statutory authorities, the allegation must also be reported to the Legion of Christ Authority and the National Board for Safeguarding Children in the Catholic Church in Ireland.

All personnel will co-operate with the statutory authorities in all cases.

In responding to complaints of child sexual abuse relating to clergy and all those in forms of consecrated life, Church authorities will act in accordance with the requirements of civil law and canon law, and so will respect the rights and uphold the safeguards afforded in these, both to the complainant and respondent.

• Caring pastorally for complainants and other affected persons

Those who have suffered child abuse by Legion of Christ Personnel will receive a compassionate and just response, and will be offered appropriate pastoral care, counselling and support as they seek to rebuild their lives. An appropriate pastoral response to the family, parish, congregation or order and to the wider community will be provided, with due regard to the right of privacy of those directly involved, and to the administration of justice.

• Caring pastorally for respondents and other affected persons

The Legion of Christ in its response to suspicions, concerns, knowledge or allegations of child sexual abuse will respect the rights under civil law and canon law of an accused cleric or religious or other Legion of Christ personnel. A legal presumption of innocence will be maintained during the statutory and Church inquiry processes. As the processes develop, additional assessment, therapy and support services may be offered to the respondent.

The Legion of Christ will take responsibility for ensuring that any cleric or religious who is considered to constitute a danger to children is managed according to a risk management plan. All requisite steps will be taken to restore the good name and reputation of anyone who has been wrongly accused of abusing a child. Respondents belong to families and diocesan or religious communities. The Legion of Christ will be mindful of the need to provide support to members of families and communities affected by the respondent's changed situation.

Risk Assessment

The table below sets out the identified risks to the safety of children and young people involved in activities at Dublin Oak Academy and the steps taken to minimise the risks of abuse. There is a procedure in place for all potential risks outlined below.

Implementation

Dublin Oak Academy is committed to safeguarding children through the implementation of *Safeguarding Children Policy and Standards for the Catholic Church in Ireland 2016*. This Child Safeguarding Statement and our practice, support our desire to keep children safe from harm while residing at our Academy in Ireland. As part of our annual audit against the relevant indicators of the child safeguarding standards, we will review the effectiveness of our practice as outlined in this statement and will revise, as appropriate.

This statement has been communicated to all staff and volunteers at Dublin Oak Academy, as well as all parents/guardians of the current Academic Year. It is available to the Agency and to members of the public on request.
